

## Speakers

**Dr. Katarina Barley** is Vice-President of the European Parliament and member of the Committee on Civil Liberties, Justice and Home Affairs and substitute member of the Committee on Foreign Affairs. In the European elections in May 2019 she was the lead candidate of the Social Democratic Party of Germany (SPD). Prior to that, she was a member of the German Bundestag from 2013 to 2019, during which time she was, among others, SPD Secretary General, Federal Minister for Family Affairs, Senior Citizens, Women and Youth, Acting Federal Minister for Labour and Federal Minister for Justice and Consumer Protection. Before her time in politics, she worked as a lawyer, research assistant at the Federal Constitutional Court

and as a judge at the Regional Court of Trier and the Wittlich District Court.



**Prof. Dr. Christian Lahusen** is professor of sociology at the Department of Social Sciences at the Faculty of Arts at Siegen University. He studied sociology in Düsseldorf and Madrid, received his PhD from European University Institute (Florence) and obtained his habilitation from the University of Bamberg. His research interests include the sociology of European societies and European integration, social movements and civil social problems and societies, social exclusion, the sociology of bureaucracy and of the transformation of the state. He has directed and participated in a number of national and international research projects on topics relating to contentious politics, civil society and social exclusion, most of them with a European and comparative perspective. Currently, he is coordinator and principal investigator of the EnTrust project (H20020). He also was coordinator and investigator of the EU-funded

project TransSOL (H2020) and a participant in other EU-funded projects such as UNEMPOL (EU FP5), YOUNEX (EU FP7), LIVEWHAT (EU FP7) and EURYKA (H2020).



**Brikena Xhomaqi** is the Director of the Lifelong Learning Platform - European Civil Society for Education (former EUCIS-LLL) since 2016. The LLL PLatform represents over 40 European wide civil society networks in the field of education from early childhood to adult education, including formal, non-formal and informal learning providers and learners. She has been elected as interim co-chair of the EESC Liaison Group of Civil Society. She is a member of the Civil Society Europe Steering Committee since 2017 and the Advisory Board member of Association Hub Belgium. She is the former Head of Office of the European Students' Union (ESU) and Director of the Erasmus Student Network (ESN). She was active in civil society

from early ages as an elected representative of different school and university student bodies.



**Anna Donáth** is a Hungarian MEP sitting in the European Parliament's Civil Liberties, Justice and Home Affairs as well as the Employment and Social Affairs Committees. She studied sociology at the Eötvös Loránd University in Budapest, and migration and ethnic studies

at the University of Amsterdam. After studies she worked in the civil sector in Hungary. A founding member of the Momentum Movement, she was vice-president of the party for two years. In 2018 during a protest she was taken by the police and became a symbol of the fight for fundamental rights in Hungary.

In the European Parliament, she focuses mainly on issues linked to the rule of law, non-discrimination, the integration of people

**Dr. Sergey Lagodinsky** is Member of the European Parliament (Alliance 90/The Greens) since 2019. He is 1st Vice-Chair of the Parliament's Committee on Legal Affairs, working in the Committee on Foreign Affairs as well as the Committee on Civil Liberties, Justice and Home Affairs. He is Chair of the European Parliament's Delegation to the EU-Turkey Joint Parliamentary Committee (JPC).

**Jean-Eric Paquet**, has been working as the Director-General for Research and Innovation (DG RTD) since April 2018.

Mr Paquet started working with the European Commission in 1993 and since then has worked in various areas throughout the Commission.

From 2002 until 2004 he was the Deputy Head of Cabinet of former Commissioner for Research, Philippe Busquin. From 2007 until 2011 he worked as a Head of Unit within the Directorate-General for Mobility and Transport (DG MOVE) before becoming the Director of DG MOVE's TEN-T and Smart Transport directorate.

Mr Paquet joined The Directorate-General for Neighbourhood and Enlargement Negotiations (DG Enlargement) in 2013. He took over the Directorate in charge of relations with Albania, Bosnia & Herzegovina, Serbia, Kosovo and later added Montenegro and the FYROM to his portfolio.



Before starting his current position as Director-General, Mr Paquet served as one of the three Deputy Secretaries-General of the Juncker Commission and was responsible for Better Regulation and Policy Coordination.
